**Job Purpose:** To maximise customer experience following the ethos and values of Urban Green Newcastle and offer public facing service and general operational support to the café management and team.

**Principal Duties and Responsibilities:**

The following is typical of the duties the postholder will be expected to perform. It is not necessarily exhaustive; duties of a similar nature and level may be required from time to time.

- Driving van whilst towing the café pod trailer safely and diligently.
- Siting, setting up and taking down the café pod.
- Undertaking health and safety checks against an operational checklist (full training given).
- Provide service of hot and cold beverages, cakes, and other food items.
- Work in close liaison with the Café Manager, Team Leader and Café staff.
- Develop and manage relationships with customers and staff.
- Manage queues and meet customer expectations, upselling to maximise profit.
- Always keep the café clean and tidy, clearing tables and waste.
- Handle customer complaints in a courteous and professional manner and reporting feedback to the Team Leader or Café Manager on duty.
- To learn all aspects of the EPOS till operation and handle customer payments.
- Follow direction from the Team Leader in all aspects of the opening and closing procedure of the café and all aspects of the daily operation to ensure smooth service.
